

**West Sussex County Council**  
**(Western Arun District: Various Roads) (Road Maintenance Programme)**  
**(Temporary Closure) Order 2022**

NOTICE is hereby given that not less than 7 days from the date of this notice, West Sussex County Council intends to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be to temporarily close, temporarily prohibit waiting at any time and temporarily introduce 20 mph speed limits on the following roads in western Arun District throughout their entire lengths unless otherwise stated:

ALDWICK: Alexander Cls, Alperton Cls, Balliol Cls, Balmoral Cls, Carlton Ave, Craigweil Ln, Edinburgh Cls, Elbridge Cres, Follett Cls, Garden Court, Grange Court, Hawkins Cls, Haydon Cls, Heston Grove, High Trees, Langley Grove, Lodge Court, Lucerne Court, Rose Green Rd from Carlton Ave to Hook Ln, Selsey Ave, St Peters Cls, Stirling Way, Stoney Stile Cls, Sudbury Cls, The Lawn, Wessex Ave. BERSTED: Shripney Road (A29) from Oldlands Way to Orchard Way. BOGNOR REGIS: Burngreave Court, Carlingford Court, Corbishley Rd/Hazel Rd from Berghestede Rd to Orchard Rd, Kyoto Court, Laburnham Grove, Mons Ave/Hampshire Ave from Hawthorne Rd to Hampshire Ave, Nelson Rd, Oak Grove from Corbishley Rd to Oak Cls, Park Terrace, Tennyson Rd, The Steyne from Manor Place to West St, Victoria Rd South. EASTERGATE: St Georges Walk. FELPHAM: Admiralty Gardens, Admiralty Road, Bereweke Rd, Culver Rd, Eastover Way, Felpham Way from Felpham Leisure Centre Roundabout to Ley Rd, Findon Dr, Fittleworth Dr, Flansham Ln from Virginia Mews to Flansham Park, Flansham Park, Gurnsey Farm Ln, Hardy Cls, Links Ave, North Way, Priestley Way from Flansham Park to Wordsworth Gardens, Pulbrough Way, Rife Way, Sarisbury Cls, The Crescent, The Midway, Uppark Way, Vicarage Ln. MIDDLETON-ON-SEA: Beaconsfield Cls, Hampden Cls, Ilex Way. PAGHAM: Buckland Dr, Drift Rd, Esher Cls, Fletcher Cls, Gloster Dr, Greenlea Ave, Leonora Dr, Malvern Way, Mayfield Cls, Nyetimber Cres, Pagham Rd from Hook Ln to Lower Bognor Rd, Pyrford Cls, Ross Cls. WESTERGATE: A29 from Nyton Rd to Charles Purley Way, Elmcroft Place.

These restrictions are needed to allow the 2022/23 road maintenance programme to be carried out in safety. Each of the affected roads are expected to be closed for up to three days. Dates for works will be confirmed in advance locally nearer the time they are carried out.

The Order will come into effect on 1 February 2022 and remain in force for up to 18 months, or until the works programme is completed, whichever is earlier.

During the operative periods of this Order alternative routes for vehicles will be indicated on site. Access to properties on the affected length of road will be maintained at all times.
