**Planning Applications considered at the Planning Committee meeting held 19th March 2024,
and Parish Council's recommendations to Arun District Council**

WSCC/014/24 – Rose Green Infant School, Hawkins Close, Bognor Regis, PO21 3LW

Retrospective application for the siting and use of 1 temporary classroom unit (variation of condition 1 of planning permission WSCC/010/19/AW to allow the continued siting of the temporary classroom for an additional five years).

No objection.

AW/53/24/T – Verge opposite Balholm, West Drive, Bognor Regis

1 No. Chestnut (T1) crown reduction to leave a height of 8-9m and radial spreads of 4-5m. Crown lift branches over the road to 5.2m over the road.

No objection.

AW/62/24/T – 2 Craigweil Lane, Aldwick, PO21 4AN

Fell 1 No. Beech (T-369) and fell 2 No. Sycamores (T-364 and T-370).

No objection.

AW/60/24/HH – 1 Heghbrok Way, Aldwick, PO21 2RF

Removal of existing conservatory and erection of single storey rear extension.

No objection.

AW/64/24/T – Land adjacent to 12 Colts Bay, Aldwick, PO21 4EH

1 No. English Oak (T1) crown lift to 3m above ground level, radial spread reductions to leave radial spreads of 3.5m and removal of major deadwood.

No objection.

AW/65/24/TC – 218 Manor Way, Aldwick, PO21 4HS

1 No. Field Maple (T1) crown reduction to leave a height of 12m and spread of 5m. Approximately 20 No. mixed species trees (G2 – mainly conifers) height reduction to leave heights of 4m. These trees are in the Aldwick Bay conservation area.

AW/61/24/T – 19 Leecroft, Aldwick Felds, Aldwick, PO21 3SY

3 No. Beech trees (T1, T2 and T3) crown reductions to leave heights of 5m and spreads of 3m.
