Minutes of the **PLANNING COMMITTEE MEETING OF THE PARISH COUNCIL**Held on **Tuesday 8th October 2024 at 7.00pm** in the Aldwick Parish Council Chamber.

48. Apologies for Absence

Apologies were received and reasons approved from Cllr Purser (personal commitment)

49. Declarations of Interest

Discussion took place on the impact of Government's proposals to increase housing development and likely impact on infrastructure.

First floor rear extensions including balcony and front detached outbuilding (amendments to previously approved AW/75/21/HH).

Two storey front, part single, part two storey side and single storey rear extensions, following demolition of existing detached garage.
