# Planning Applications considered at the meeting held 4<sup>th</sup> March 2025, and Parish Council's recommendations to Arun District Council

AW/9/25/T - Land between 18 & 19 The Fairway Bay Walk Aldwick PO21 4ES.

2 No. Lombardy Poplars (T1 & T2) crown reductions to leave heights of 14-15m and radial spreads of 3m. **NO OBJECTION.** 

#### AW/26/25/TC - 86 The Fairway Aldwick PO21 4EX.

1 No. Sweet Bay (T1) dismantle and fell to ground level. After discussion it was agreed to **OBJECT** owing to no reasons for the felling of the tree and they would request this application be referred to the Arun DC Tree Officer.

#### AW/27/25/HH - 5 Windmill Close Aldwick PO21 4ND

Two storey side/rear extension, new front porch, detached garage with dormer and alterations to fenestration, following the demolition of existing rear conservatory and garage. After discussion it was agreed to **OBJECT** on the grounds of over development.

Reduce crown of 1 No Beech by 4 m to a final height of 8m and spread of 7m. NO OBJECTION

Crown reduction of 2-3m back to previous pruning points and crown clean removing all dead wood to 4 No Horse Chestnut trees (T1871,T1872,T1873 & T1874). **NO OBJECTION**

1 No. Silver Birch (T1): crown reduction to leave a height of 6m and spread of 3.5m, 1 No. Hawthorn (T2): crown reduction to leave a height of 5m and spread of 3m, 1 No. Indian Bean (T3): crown reduction to leave a height of 5m and spread of 4m, 1 No. Beech (T4): crown reduction to leave a height of 5m and spread of 3m within Aldwick Bay Conservation Area. **NO OBJECTION**
