#### Questions from members of the public -

- Vice Chairman of the West Mead Residents committee requested a metal gate for the exterior of the cricket club as a deterrent to ongoing anti-social behaviour.
  - The Chairman responded that Arun District Council own the grounds which are managed by a contractor. The Chairman stated that the Cricket Club can apply for discretionary grant from the Parish Council and permissions from the landowner/property owner must be included.
- A resident requested that a dog bin be placed at the beach café opposite Marine Park Gardens. The Clerk responded that there are more than three bins in West Park and one at the Waverly and that there would be an issue around health and safety regarding placing the bin near a restaurant or the beach

- huts. The Clerk informed the resident that ordinary bins can be used provided proper disposal bags are used.
- A resident requested that a visual sign be placed for No Cycling at the Waverly end of the beach to
  prevent cyclists who may not speak English using the path. The Clerk stated that the signage regarding
  the issue of cyclists is being dealt with by Arun District council.
