## Council extends free town centre parking to three hours

## Face masks to be worn in shops from 24 July

The government has announced that face masks must be worn in shops from 24 July. The Council will be providing posters around shopping areas in the district from that date to remind shoppers that this is now compulsory, except for those who are exempt – which includes children under 11 and those with certain disabilities. As more traders in the district reopen, including beauty salons [excluding facial treatments], tattoo shops and hairdressers, we would again ask people to continue to support our local shops and businesses, to pay attention to social distancing guidelines and to stay safe.

## Dogs in open spaces and on beaches – have your say

We are reviewing the rules for dogs in public and want to hear what you think! A public consultation has been launched to seek your views on plans to amend and continue the current Public Space Protection Order for dogs in open spaces. The proposed changes are designed to 'fine-tune' the existing order and are based upon feedback from the public and our first-hand experience in managing land and enforcement issues in relation to dog controls. The changes include allowing dogs in Marine Park Gardens in Bognor Regis and Marina Gardens in Littlehampton, as long as they are on leads under control, and requiring dogs to be kept on a short lead in cemeteries and churchyards.
